ORDER:

The following Notification will be published in the Extraordinary issue of the Telangana State Gazette on 01-02-2021.

NOTIFICATION

In exercise of the powers conferred by Sub-Section (1) of Section-47 of the Telangana Fire Services Act, 1999 (Telangana Act No. 15 of 1999) the Governor of Telangana hereby makes the following amendments to the Telangana Fire & Emergency Operations and Levy of Fee Rules, 2006 issued in G.O.Ms.No.306, Home (Prisons. A) Department, Dated:7-12-2006 and as amended from time to time.

AMENDMENT:

In the Said Rule:-

(1) In Rule :- 19 after sub-rule (8) the following rule shall be added, namely,

“9 (a) License may be granted by the Authorised Officer in Form No. 6-A for Amendment of Fire Service License.

(b) A license may be granted by the Authorised Officer in Form No. 6-B for Death or Disability or Insolvency of Fire Service License.

(c) A license may be granted by the Authorised Officer in Form No. 6-C for Duplicate fire service license.

(d) A License may be granted by the Authorised Officer in Form No. 8-A for renewal of Fire Service License”.

(2) In Rule :- 20 after sub-rule (3) the following rule shall be added, namely,

“(4) A licensee shall get his license amended when there is a change in the name of the premises or ownership or in the limits specified in the licence in regard to the nature and quantity of hazardous materials to be handled when he submits an application in prescribed proforma of Form - 5A

(3) In Rule 22,

(a) as the existing paragraph shall be numbered as sub-rule (1)

(b) after the existing para, so re-numbered as sub-rule (1) the following sub-rule shall be added namely;-

“(2) If a licensee dies or becomes insolvent, the persons carrying on the business of such license shall submit an application for amendment in prescribed proforma of Form-5B”

(4) In Rule 23,

(a) the existing paragraph shall be numbered as sub-rule (1)

(b) after the existing para so re-numbered as sub-rule (1) the following sub-rule shall be added namely:-

"(2) where a license granted or renewed under these rules is lost or accidentally destroyed, a duplicate may be granted by the authorized officer on submission of application in prescribed proforma of Form-5C".
